  - ❖ Form Anti ragging squad to make surprise visits and take effective steps to prevent ragging.
  - ❖ Oversee the procedure of obtaining undertaking from the students in accordance with the provision.
  - ❖ Conduct workshop against the ragging menace and orient the students.
  - ❖ To provide students the information pertaining to contact address and telephone no of the person identified to receive complaints/ distress call.
  - ❖ To offer service of counseling and create awareness of ragging inside the campus/ Hostel.
  - ❖ To take all necessary measures for preventing of ragging inside the campus/hostel.
